THERE ARE A FEW INSTANCES, AS EXPLAINED BELOW, IN WHICH A COMMUNITY RENAISSANCE FUND BOARD MEMBER HAS OR MAY HAVE A BUSINESS RELATIONSHIP WITH THE FOUNDATION OR ANOTHER OF THE FOUNDATION'S TRUSTEES.

ONE OF THE STRENGTHS OF OUR ORGANIZATION IS THAT ITS GOVERNANCE IS STRUCTURED TO ENGAGE KEY COMMUNITY LEADERS FROM ALL BUSINESS ASPECTS AND GEOGRAPHIC AREAS OF THE COUNTY AND THIS PHILOSOPHY IS CARRIED OUT THROUGH ITS SUPPORTING ORGANIZATIONS. GIVEN THIS APPROACH, THERE INEVITABLY WILL BE SOME SITUATIONS WHERE A RELATIONSHIP MAY ARISE. IN EACH OF THESE INSTANCES, HOWEVER, THE FOUNDATION HAS TAKEN MEASURES TO MAINTAIN TRANSPARENCY, KEEP ANY TRANSACTION AT ARM'S-LENGTH, AND ENFORCE ITS CONFLICT OF INTEREST POLICY.

ACHESON II FUND MAY PERIODICALLY MAKE GRANTS TO SUPPORT THE PROGRAMS, PROJECTS AND INITIATIVES OF THE COMMUNITY RENAISSANCE FUND, WHICH WOULD BE EXPECTED GIVEN WE ARE THE LARGEST COMMUNITY-BASED CHARITABLE ORGANIZATION IN THE COUNTY. EACH GIFT IS IRREVOCABLE AND IS HANDLED IN THE SAME MANNER AS EVERY OTHER CHARITABLE GIFT RECEIVED.
